## 9. Executive Report 2022-2023

John Henly highlighted key accomplishments of the past year, including:

- a) KNPS delegation to the City of Kimberley strengthen and clarify relationships. John introduced Sue Cairns, the City's new liaison to the board. He briefly spoke of the park's agreements with the City and Province.
- b) Involvement and partnership with Will Booth of the Kimberley Fire Department, in the work related to wildfire reduction and fuel treatment within the park. The fire interface committee members are Kent Goodwin, Dave Hale, Laura Duncan, John Henly and Jean Terlesky.
- c) Establishing a relationship with Chelsea Hollister from Lands BC. John explained the 'new to the board' understanding of provincial land tenures especially Recreational Tourism Tenures. Jean Terlesky did research. John explained the Horse Barn Valley Interpretative Forest designation and the role of Lisa Cox and Recreation Sites and Trails BC.
- d) New Nature Park Trail Guide: appreciation to Ryan McKenzie and the Kimberley Trails Society; Lori Craig, President of the Nordic Club; the City of Kimberley, Trans Canada Trails, Friends of Lois Creek and special thanks to professionals Jim Webster and Janice Strong for volunteering hundreds of hours to produce the Trail Guide.
- e) The Nature Park updated the logo and now has a family of logos that will be used on all Society publications. Maurice Frits was introduced and thanked for his professional eye and special society discount fee.
- f) Letters of support for commercial bike operations (Shred Sisters, RideTheory), Black Spur race, and ongoing support for Freewheelers. John introduced Christine Ma from RideTheory and acknowledged her as a patient participant in our learning process of tenure applications.
- g) Ongoing interactions with groups such as Friends of Lois Creek, Kimberley Nordic Club and Ryan McKenzie (KTS) for collaborative work on park trails.

- h) Working with East Kootenay Invasive Species Council to deal with invasive weeds in the park, and Dave Hale's contribution of a boot brush.
- i) The work that continues with Wildsight Education and programs, The Nature Conservancy, The East Kootenay Climbing Association. There is an MOU with KNPS and the Climbing Association outlining a sensitive area in Horse Barn Valley where the red-listed Umbillcaria hirsuta, or Hairy Navel Lichen, exists.
- j) John also recognized Kimberley Nature Park funders:
  - Columbia Basin Trust Non-Profit Advisor program: supporting the board with ways to enhance strategic planning, governance and marketing. Ingrid Liepa was introduced as the CBT consultant to work with the board.
  - Teck provided a grant for the purchase of wildlife cameras. Thanks to Laura Duncan for project lead and Lyle Grisedale for all his work.
  - City of Kimberley Community Grants: \$3,813 to purchase trail counters and additional wildlife cameras, and a previous grant for the Trail Guide.
- k) Other KNP activities: Pride Day, Annual Girl Guide Night Trek, Flannel Fest bike race, Black Spur Ultra, Round the Mountain, the Firewood Salvage Program run by Andy Miller, Kayla Wilson and 44 volunteers.
- I) Horse Barn Valley bridge construction, thanks to Struan Robertson and family with a grant from Rec Sites BC.
- m) Landscape Photo Documentation project, Calypso orchid count, the placement of a Memorial bench
- n) Goals for the Society in 2024 include:
  - CBT Non-Profit Advisors Program: complete tasks and incorporate recommendations
  - Continue work to revise the KNP Management Plan
  - Pika research: partner with the BRAES Institute (The UBC Okanagan Institute for Biodiversity, Resilience, and Ecosystem Services) to study the park's pika population
  - Promote the conservation aspect of Park and research programs
  - Continue with grant applications, thanks to Jen McConnachie, Kent Goodwin and Gary Hicks.
