

# **Appendix B: Public Consultation Summary**

## **Consultation Update July 2019**

At the beginning of 2019 the KNPS carried out a review of the KNPS Management Plan. A planning committee was convened to revise any out-of-date sections and to refresh the lists of action items, removing any that had been fully accomplished and extending those that needed to continue. Appendices were also reviewed and updated. The new draft plan was reviewed by the KNPS Board of Directors at the April 25<sup>th</sup> monthly meeting and then posted on the KNPS website for public review. No input was received from the public. The plan was sent to the City for approval and forwarding to the Province of BC in the fall of 2019.

## **Consultation Update, July 2012**

In the spring of 2012 the Province of BC offered to renew the City's License of Occupation for the Nature Park for a period of 30 years. A condition of this renewal was the need to review and update the KNP management plan. Members of the KNPS Planning Committee carried out this review in June and a draft copy of the new version of the plan was posted on the KNPS website for public comment in July. Finalization of the plan occurred in the fall of 2012.

## **Consultation Update, February 2009**

In 2008 the KNPS Planning Committee, in consultation with City Councillor Bob West-Sells, reviewed and update the Nature Park Management Plan. A draft version then posted on the Nature Park website and the public was invited to submit their comments. In January 2009, the KNPS Planning Committee incorporated the public feedback into the document. AT the January 29th, 2009 monthly KNPS membership meeting, a motion was passed to accept the amended plan and forward it to the City of Kimberley. The Plan was then submitted to and accepted by the Province of BC.

## **Public Consultation 2002-2003**

The preparation of the original version of this plan involved consultation over a 15-month period with a wide variety of groups and individuals including neighbouring landowners, government agencies, various experts, community groups and the general public.

Two public meetings were held at Selkirk High School, one on June 20<sup>th</sup> 2002 to refine a list of major issues to be considered and another on May 15<sup>th</sup> 2003 to discuss the draft management plan.

A two-page questionnaire was created and distributed in October 2002 seeking public feedback on a number of issues. Copies of the questionnaire were placed at the

Kimberley Public Library, the Snowdrift Café, Bavarian Hardware, Techno Sport, Loon Lake Café, Marysville PetroCan, the Bean Tree and the Barking Gecko. Eighty-four responses were received and considered.
